B Objectives

1. What is the main purpose for this course?

Course Description:

This course examines the management of assets and liabilities in a multinational setting. The primary topic to be covered is the evaluation and management of a foreign exchange risk. Evaluation of FX risk is done within an investment optimization framework. Management topics include pricing and application of foreign exchange derivatives: swaps, futures and options. The course also examines the special problems encountered by the international financial officer: 1) the multiplicity of currencies, and the attendant problems related to nominal contracts, 2) the misalignment of exchange rates vis-à-vis local costs and the attendant problems of competitiveness, 3) the partial segmentation of capital markets producing potential differences in costs of capital across the world and 4) the multiplicity of tax jurisdictions.

Purpose of the course:

- 1. To understand the evaluation and management of foreign exchange risk and speculative FX trading strategies.*
- 2. To examine the valuation of foreign exchange securities.*
- 3. Familiarize students with the array of financial innovations brought about by the international capital markets and global financial institutions.*
- 4. Analyze issues and concepts of modern international finance using historical, institutional, economic, and managerial paradigms.*

Suggested assessment methods and teaching strategies are:

According to research and best practices, multiple and continuous assessment methods are required to verify student learning. Current trends incorporate a wide range of rubric assessment tools; including web-based student performance systems that apply rubrics, benchmarks, KPIs, and analysis. Rubrics are especially helpful for qualitative evaluation. Differentiated assessment strategies include: exams, portfolios, long and short essays, log books, analytical reports, individual and group presentations, posters, journals, case studies, lab manuals, video analysis, group reports, lab reports, debates, speeches, learning logs, peer evaluations, self-evaluations, videos, graphs, dramatic performances, tables, demonstrations, graphic organizers, discussion forums, interviews, learning contracts, antidotal notes, artwork, KWL charts, and concept mapping.

Differentiated teaching strategies should be selected to align with the curriculum taught, the needs of students, and the intended learning outcomes. Teaching methods include: lecture, debate, small group work, whole group and small group discussion, research activities, lab demonstrations, projects, debates, role playing, case studies, guest speakers, memorization, humor, individual presentation, brainstorming, and a wide variety of hands-on student learning activities.

<p>1 Strategies for Obtaining Student Feedback on Effectiveness of Teaching</p> <ul style="list-style-type: none">▪ <i>During week 13 and 14, the YU's "Student Affairs" department conducts a survey covering all aspects relating to their learning experience for the concerned course. Students are given questionnaire on different areas of the course including the effectiveness of the course.</i>▪ <i>There are two ways that the survey is undertaken: manually by distributing the printed forms to the students during the class meeting hours and by electronically, where students are required to go to the computer lab for participating in the survey.</i>▪ <i>The responses are forwarded to the "Information Center" where it is analyzed and reports are prepared.</i>▪ <i>The report is called "Course Evaluation Survey" or CES and is submitted to the department chairman, who shares the report with the respective faculty members.</i>
<p>2 Other Strategies for Evaluation of Teaching by the Program/Department Instructor</p> <ul style="list-style-type: none">▪ <i>Classroom observations are conducted by the dean during class periods, especially for the newly recruited faculty members.</i>▪ <i>A form with some standard questions regarding classroom activities is used to evaluate the performance of the faculty members during the classroom visits.</i>▪ <i>Faculty members are informed about the classroom visits without notifying a specific day for the visit.</i>▪ <i>The reports are shared with the faculty members.</i>▪ <i>In addition to a self-evaluation form to be completed by the teacher himself.</i>
<p>3 Processes for Improvement of Teaching</p> <p><i>The process for improving the teaching includes the following:</i></p> <ul style="list-style-type: none">▪ <i>Workshops and seminars are conducted throughout academic year to address specific teaching strategies and improvements.</i>▪ <i>Feedbacks from students using different types of survey are shown and discussed with faculty members to improve the teaching.</i>
<p>4. Processes for Verifying Standards of Student Achievement (e.g. check marking by an independent member teaching staff of a sample of student work, periodic exchange and remarking of tests or a sample of assignments with staff at another institution)</p> <p><i>At the end of each semester, every teacher are required to submit the original answer script along with the question paper to the department which will be preserved for two semesters. This helps in processing the grade appeal issues and it also serves as a repository of course folder.</i></p>
<p>5 Describe the planning arrangements for periodically reviewing course effectiveness and planning for improvement.</p> <ul style="list-style-type: none">▪ <i>At the end of each semester, Curriculum committee conducts a meeting with all faculty members in which surveys filled by the students and other feedbacks from faculty members are discussed. Effectiveness of the courses, mistakes done and weaknesses are discussed. These points are made basis for the planning for improvements for next semester/ year.</i>
